The Spay/Neuter Assistance Program (SNAP) provides spay/neuter financial assistance to qualifying low-income dog and cat owners. Pet owners must provide proof of participation in a needs-based public assistance program in Indiana when applying for a certificate. The certificate is valid for a single spay/neuter surgery at any of the over 110 participating veterinarian clinics across the state. Since inception in 1977, over 110,000 animals have been fixed under this program.

4b (Code:) (Expenses \$ **104,802** including grants of \$ **104,802**) (Revenue \$)
The Pet Friendly Group Grant program provides 10 free surgery certificates to non-profit animal welfare groups and municipal shelters so they can spay/neuter animals in their care before making them available for adoption into permanent, loving homes.

4c (Code:) (Expenses \$ **192,546** including grants of \$ **192,546**) (Revenue \$)
The Community Cat program provides free surgery certificates to non-profit animal welfare groups and municipal shelters that Trap-Neuter-Return (TNR) feral and free roaming cats. This strategic program prevents these cats from ever entering shelters.
