Contract between Pet Friendly Services and Participating Veterinarians

Our clinic agrees to spay and neuter dogs and cats through Pet Friendly Services' programs at the following reimbursement rates. We understand that, if our clinic's posted rates are lower than those listed below, Pet Friendly Services will reimburse the clinic at our posted rates, provided they do not exceed the rates listed below.

Spay-Neuter Assistance Program (SNAP) Certificates

The SNAP program is for low-income, qualified Indiana residents.

Community Cat Program Grant (CCP) and Spay-Neuter Assistance Program (SNAP) Certificates for Individuals Helping Community Cats (SNAP-CC) Certificates

The Community Cat program is for feral and free-roaming cats.

🐾 The surgery reimbursement schedule above includes ALL costs associated with the surgery, including: office call, anesthesia, pre and post care, and pain medicine given at the time of surgery.


Pet Friendly Plate Grant - Coupon Program (PFPG-CP)


NEW in 2025 - The Pet Friendly Plate Grant provides discount coupons to shelters and rescues instead of certificates. Pet Friendly Services will reimburse your clinic \$100 per dog and \$50 per cat, with the shelter/rescue paying the remaining bill.

Pet Friendly Services of Indiana will reimburse the coupon amount upon completion of the surgery. The remainder of the surgery cost will be paid to the vet clinic by the shelter/rescue.

 The only vaccine required by Indiana law is the rabies vaccine, and the client is financially responsible for this. It is also the client's responsibility to ensure their pet(s) is free of fleas and ticks. If they are not, the financial responsibility for a flea/tick treatment falls on the client.

 Indiana requires that all animals be current on their rabies vaccine, and I accept proof of vaccinations from other clinics or veterinarians. **Vet Initial (optional):** _____

 We recognize that **Spay-Neuter Assistance Program (SNAP/SNAP-CC)** clients are on limited-incomes and require no other services (e.g. heartworm or feline leukemia checks, kennel cough vaccinations, boarding charges, antibiotics, stool check, de-worming, pre-surgery bloodwork, etc.). If these services are offered, our clinic staff will communicate that they are **OPTIONAL, PRIOR TO THE SURGERY** and that the client is financially responsible for them. **Vet Initial:** _____

 Our clinic would like to participate in the **SNAP program** and agree that we will not charge PFS clients for any services related to the surgery. **Vet Initial:** _____

 Our clinic would like to participate in the **CCP/SNAP-CC program** providing surgeries, rabies vaccine and mandatory eartip to feral and free-roaming cats. **Vet Initial:** _____

🐾 The nonprofit rules dictate that Pet Friendly Services file a 1099 each year for any organization to which we pay at least \$600 for performing services on our behalf. In order to properly submit this information to the IRS and our vendors, it is necessary for us to request your information on a W-9 so that we will have it in the event it becomes necessary to issue you a 1099 at the end of the year. This information is treated with the utmost confidentiality and is not shared with anyone within or outside of the organization that does not have a legitimate need to know.

🐾 I realize that Pet Friendly Services may reimburse our clinic \$600 or more and is required by the IRS to have a completed W-9 form from my business before adding me to the vet network. **Vet Initial (required):** _____
